# STREAMWOOD PARK DISTRICT ORDINANCE 2019-12-1-O

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE STREAMWOOD PARK DISTRICT, BEING A LEVY FOR THE CORPORATE FUND, RECREATION FUND, MUSEUM FUND, ILLINOIS MUNICPAL RETIREMENT FUND, SOCIAL SECURITY FUND, AUDIT FUND, LIABILITY INSURANCE FUND, SPECIAL RECREATION FOR PERSONS WITH DISABILITIES FUND, AND PAVING & LIGHTING FUND, SAID STREAMWOOD PARK DISTRICT BEING IN THE COUNTY OF COOK, STATE OF ILLINOIS, AND SAID LEVY BEING FOR THE YEAR 2019.

WHEREAS, heretofore to wit; on the 30<sup>th</sup> day of April, 2019, the Board of Commissioners of the Streamwood Park District, Cook County, Illinois, passed its annual Appropriation Ordinance which was approved on April 30, 2019, and said Appropriation Ordinance now being in full force and effect;

**NOW THEREFORE, BE IT ORDAINED** by the Board of Commissioners of the Streamwood Park District, Cook County, Illinois;

Section 1. That there be and is hereby levied and assessed upon all taxable property within the corporate limits of the Streamwood Park District, Illinois, as the same is assessed and equalized for state and county taxes, for the construction and maintenance of parks in the Streamwood Park District in the County of Cook, State of Illinois, and for the necessary expense of said District for the fiscal year 2019, the total amount hereby levied and assessed for the Corporate Fund, Recreation Fund, Museum Fund, IMRF Fund, Social Security Fund, Audit Fund, Liability Insurance Fund, and Special Recreation For Persons with Disabilities Fund: \$3,797,145.00.

Section II. That the taxes so levied as assessed as aforesaid upon the taxable property subject to taxes within the Streamwood Park District, shall be collected and enforced in the same manner and by the same officers as general taxes are now collected and enforced under the laws of the State of Illinois and shall be paid by officers so collecting the same to the Treasurer of said Streamwood Park District.

Section III. That the Secretary of the Streamwood Park District be and is hereby directed to file with the County Clerk of Cook County, State of Illinois, provided by law to ascertain that rate percent which, upon the total valuation the same assessed are equalized for state and county purposes, will produce a new amount as herein legally levied, and to extend such tax pursuant to the statute.

<u>Section IV</u>. If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining such items of the remaining portion of this Ordinance.
