MINUTES OF THE REGULAR MEETING OF THE STREAMWOOD PARK DISTRICT BOARD OF COMMISSIONERS HELD ON MARCH 20, 2018 AT HOOSIER GROVE BARN, 700 W. IRVING PARK ROAD, STREAMWOOD, ILLINOIS

CALL TO ORDER/ROLL CALL

President Wright called the meeting to order at 7:00 p.m. Present were Commissioners Brogan, Armstrong and Yawer, along with staff members Executive Director Dennis Stein, Superintendent of Business & HR Jennifer Hermonson, Superintendent of Recreation Kurt Reckamp and Finance Manger Sherri Harry. Commissioner Brogan noted that the Corporate Fund budget has a net of -\$612,777.35. Executive Director Stein explained that since the Corporate and Recreation funds are the only unrestricted funds we are going to transfer funds from the Corporate Fund to the Recreation Fund, Insurance Fund and the Social Security Funds in order to reduce their fund balance deficits. Executive Director Stein stated that the budget must be passed and approved within or before the end of the first quarter of each fiscal year and also the budget must be available for public inspection at least 30 days prior to the final action.

D. Custodial Bids

Commissioner Brogan asked if the references for Perfect Cleaning Service Corp. were good and Superintendent of Business & HR Hermonson said they were and said that they quickly respond to any issues that might come up. She also said that part of the bid specifications were references of projects similar in size. The specifications also called for pricing on a yearly basis for a three year period with the contract renewable on an annual basis.

Commissioner Brogan moved approval of the bid from Perfect Cleaning Service Corp. for custodial services during fiscal year May 1, 2018 to April 30, 2019 in the amount not to exceed \$66,450.00. The motion was seconded by Commissioner Yawer. Vote on the motion:
