# **DEPARTMENTS/DIRECTOR'S REPORTS**

- A. Superintendent of Recreation Muenz informed the Board that Hoosier Grove Barn has been moved from the Business Department to the Recreation Department. He said the Barn revenue for May totaled \$52,465 and currently has 61 weddings booked for 2019 and 45 for 2020 which is 15 more than last year at this time.
- B. Superintendent of Recreation Muenz said that the Streamwood Stride took place on June 8<sup>th</sup> with 173 total runners compared to 196 runners last year. Staff will be reviewing this year's race and see what changes might be needed to keep registration up.
- C. Superintendent of Recreation Muenz stated that we will be hosting our first Fitness in The Park on June 27<sup>th</sup> at Oak Ridge Park from 6-7 p.m.
- D. Superintendent of Recreation Muenz said that the Summer Kick-Off took place on June 11<sup>th</sup> and thought it went very well. He said that the district hosted approximately 300 people for the event.
- E. Superintendent of Recreation Muenz informed the Board that our new Museum Manager, Ruby Nava, has started with the district and is excited about cataloging the items in the farmhouse and working with the public for tours.
- F. Superintendent of Recreation Muenz also mentioned that Starlights participated in their last competition of the season, the theater program began with auditions on June 11<sup>th</sup>, the SPD Summer Slam is set to begin on July 11<sup>th</sup> and that Starguard came out last month and our lifeguards scored a 4 out of 5 during the first audit of

- the 2019 season.
- G. Superintendent of Parks & Planning Pickett said that we will be posting the job for the Parks Supervisor of Fleet and Mowing position in the next week.
- H. Superintendent of Parks & Planning Pickett said we have been busy setting up for Summer Kick-Off, the Streamwood Stride and several baseball tournaments.
- I. Superintendent of Parks & Planning Pickett stated that they are finally catching up at mowing all the sites and that since spring soccer season is over we have started repairing the turf.
- J. Superintendent of Parks & Planning Pickett informed the Board that both asphalt projects at Dolphin Park and Sunny Hill Park are complete with just a few remaining punch list items. He said that Dolphin Park ballfield restoration will be completed before the Streamwood Little League fall season starts.
- K. Superintendent of Parks & Planning Pickett informed the Board that we will be renovating the Dolphin Park volleyball court in the coming weeks.
- L. Superintendent of Parks & Planning Pickett said that Sunny Hill splash pad is open from 11:00 a.m. 8:00 p.m.
- M. Interim Executive Director Piekarz congratulated Fitness & Membership Manager Saros on a great job on the Streamwood Stride event.

## **COMMISSIONERS' REPORT**

- A. Commissioner Janiec thought the Streamwood Stride went well although there was one minor complaint that he turned over to Interim Executive Director Piekarz and he resolved it with the patron.
- B. Commissioner Janiec said that the Summer Kick-Off event went great.
- C. Commissioner Janiec wondered when the park bench for the late Tom Keating was going to be dedicated to him and President Wright responded that he had talked to his wife, Diane Keating, and she and her family just aren't ready for it yet but maybe in the fall.
- **D.** Commissioner Armstrong reminded everyone that there will be a Blood Drive tomorrow at the Village of Streamwood Police Station.

A. President Wright said he thought the Streamwood Stride and the Summer Kick-Off event went really well.
