# F. Park Place Parking Lot Electrical Work Preview

Assistant Superintendent of Parks & Planning Pickett informed the Board that the south side parking lot lights at Park Place are out and the outage is now starting to spread to the front of the building. He stated that in August staff met with W-T Engineers to discuss the electrical problems and in November we received two options which were trenching or directional boring and that both options would include replacing all underground electrical wiring.

Commissioner Brogan asked if it had anything to do with when we repaired the parking lot which Assistant Superintendent of Parks & Planning Pickett responded that it did not and that it was an underground problem.

Commissioner Wright asked if we could look into solar and green options which Assistant Superintendent of Parks & Planning Pickett said he would look into those suggestions. Executive Director Stein said that they will talk to W-T and come back to the Board with additional information.

Commissioner Brogan suggested that maybe a Commissioner should be present at a meeting with W-T Engineers.
