DEPARTMENTS & DIRECTOR'S REPORT

- 1. Superintendent Muenz stated that staff had attended the IPRA PDS School this month. Two staff completed their 2nd year of the program and Steve is on the programs Board of Regents.
- 2. The Hoosier Barn rental revenues were \$83,000 with a \$51,000 net and included 9 weddings and 3 rentals which reflects a 9% increase over same period in 2018. The HGB had 52 appointments to see the Barn for possible rentals and weddings in October. There ae 63 weddings booked for 2019, 66 booked for 2020 and 8 booked for 2021.
- 3. Commissioner Janiec asked if there were any complaints related to the driveway and lack of lighting at HGB. Staff replied no and that they would look into the status of the lighting repairs.

- 4. Several staff attended the PDRMA RMI.
- 5. Staff attended 2 health and wellness fairs this month, one at the Streamwood Police Department and the other at Elgin High School.
- 6. Fitness membership sales for October were 102 memberships with \$18,761 in revenue. Last October saw 80 memberships sold with \$13,727 in revenue.
- 7. Safely Trick or Treat had 300 attendees and received \$700 in donations along with inkind donations.
- 8. Breakfast with Santa is December 7th at HGB.
- 9. December 15th is the Santa Storytime Express. This year the trip will take the METRA from Bartlett to Wood Dale where Santa will board the train.
- 10. Preschool fundraising has raised \$8,600 through raffles and fundraising. An additional \$5,300 was raised through cookie dough sales. This money is earmarked for the theatre program.
- 11. The new website is up and running. Staff is working on a new chat function that will allow a user to chat with a staff member for assistance.
- 12. Staff are working on a sponsorship program for the District.
- 13. The meet Jeff Janda post on Facebook garnered 2,100 looks 180 engagements, 16 likes and 5 shares.
- 14. Athletic and birthday rentals are up from last year at this time. Birthday parties are at \$1,455 up from \$900 and Community Center Rentals are at \$4,200 up from \$3,150.
- 15. Aquatic swim lesson registrations are at 44 registered, down from 49 last year.
- 16. A life guard class will be held to add two more guards to the rotation.
- 17. Superintendent of Parks and Planning Ian Pickett stated that the District had 2 snow events and 3 deicing events so far this season.
- 18. Staff are winterizing and working on preventative maintenance as needed.
- 19. Commissioner Janiec asked if the volleyball court nets have been removed for the season. Staff replied yes.
- 20. Grow blankets have been installed on turf areas at Hoosier Park to assist with turf regrowth.
- 21. Staff are busy installing holiday decorations.
- 22. Several of the parks staff attended the PDRMA RMI.
- 23. The last light pole at Park Place has been installed. Punch list items will be addresses in an upcoming walkthrough.
- 24. Larry Piekarz congratulated Ian Pickett for his grant reporting work with the Illinois Deportment of Economic Opportunity and Steve Muenz for his work on the National Fitness Campaign project.
- 25. Executive Director Janda asked the Board members present if there is an interest for computer tablets to be issued to them to assist with Board packets and park district business. Based on the positive response, tablets will be acquired and set.
- 26. The TCP Payroll clocks should be operational in December with full implementation in

January.

- 27. Executive Director Janda attended the NWSRA meeting and Board related training.
- 28. The 2019 Tax Levy has been prepared with assistance from Auditor Julius and reviewed by Attorney Rock.
- 29. Bi-Weekly Department Head meetings are being held at the Community Center in the remodeled conference room.
- 30. Executive Director Janda met with Attorney Rock to discuss park district matters and ongoing issues.
- 31. Staff attended a conference/seminar on Weed in the Parks and have suggested an Ordinance change reflecting that consumption of cannabis is prohibited on park district property. The ordinances will be reviewed in the future and amended as needed.
- 32. Executive Director Janda and Superintendents Pickett and Muenz met with Auditor Julius to review the 2018 Audited Financial Reports and to provide the Superintendents a better understanding on the audit and its process.
- 33. Superintendent Picket and Executive Director Janda have met with the Hitchcock Group related to the design of Commissioners' Park.
- 34. Staff will be meeting with DLA Architects to discuss and review potential costs on several proposed projects.
- 35. Executive Director Janda attended the IAPD Legal Symposium and the PDMRA RMI.
- 36. Employee Health Insurance Open Enrollment has ended and is complete.
- 37. Commissioners Janiec, Wright, and Executive Director Janda attended the Streamwood Chamber of Commerce this month.
- 38. Janda reported that several new laws are taking effect that will impact the park district. A non-inclusive list includes:
 - Open Meetings Act Changes- Closed Session is now legal for volunteer and contracted employee related issues.
 - Equipment leasing has been changed from 5 years to 8 years to allow better terms and savings.
 - FOIA-Credit/Debit Card numbers and bank account numbers are now exempt from release.
 - Minimum wage is increasing to \$9.25 January 1, 2020. The District will see an estimated \$35,000 impact in the first six months.
 - Sexual Training requirements have changed. Annual training is now required along with policy update.
 - Cannabis is legal with restrictions beginning January 1, 2020.
 - Investment Policy language changes are also occurring with required updates in 2020.
 - Baby changing stations are now required in all single stall bathrooms.
 - Single use bathrooms need to be non-gender identified on the signage.

Commissioner Janiec also asked about the status of the lighting at Hoosier Park. Staff will contact HR Green tomorrow.
