## **DEPARTMENTS/DIRECTORS'S REPORT**

- A. Superintendent of Reckamp noted that summer day camp training is starting next week, the Dance Recital is on June 2<sup>nd</sup>, the Streamwood Stride will be on June 10<sup>th</sup> and the Summer Kick-Off event will be on June 13<sup>th</sup> and it will be in conjunction with the Poplar Creek Library.  
Commissioner Brogan asked how many Men's Softball teams we have and Superintendent of Recreation Reckamp responded that we have five teams.
