MINUTES OF THE REGULAR MEETING OF THE STREAMWOOD PARK DISTRICT BOARD OF COMMISSIONERS HELD VIA ZOOM ON TUESDAY, JANUARY 26, 2021

The meeting will be conducted by audio or video conference without a physically present quorum of the Streamwood Park District Board of Commissioners because of a disaster declaration related to COVID-19 public health concerns affecting the jurisdiction of the Park District. President Wright has determined that an inperson meeting at the Hoosier Grove Barn, 700 W. Irving Park Road, with all participants is not practical or prudent because of the disaster. Commissioners, the Executive Director, Staff and chief legal counsel will not all be physically present at the Hoosier Grove Barn, 700 W. Irving Park Road, due to the disaster. Physical public attendance at the Hoosier Grove Barn, 700 W. Irving Park Road, may be limited or not feasible, so alternative arrangements for public access to hear the meeting are available. The meeting will also be audio or video recorded and made available to the public as provided by law.

CALL TO ORDER/ROLL CALL

POLICY AND PLANNING REPORT

A. Resolution 2021-01-R: Amending Full-Time Salary Ranges

Executive Director Janda stated that it appears that the last time full-time salary ranges were fully reviewed was in 2012 which has led to long tenured employees' wages being out of range and doesn't reflect the market value. He said that salary ranges need to be reviewed every few years in order to maintain competitive to retain and reward great employees.

Commissioner Armstrong asked if it was for all full-time positions and Executive Director Janda said yes it was for all full-time positions.

B. Extension of Families First Coronavirus Response Act (FFCRA or Act) Benefits that Expired on 12/31/2020 to Allow Staff to Carry Forward Unused FFRCA Days (up to 10 paid days) that for Covid-19 Sick Days Until 03/31/2021

Executive Director Janda informed the Board that as of December 31, 2020 none of the employees have requested this benefit.

C. Request to Deny Village of Streamwood Use of Hoosier Grove Park for Summer Celebration in 2021 Due to Covid-19 Related Concerns

President Wright stated that he had talked to some people, including two mayors, and they all felt that they are going to have to wait until May to see what, if any, summer activities they will be able to have. President Wright said that they all feel more data is needed and he agrees with them. Commissioner Brogan said that he agrees with President Wright and that if it not safe by May we will not be able to have the Summer Celebration event. He also said that it might be a good idea for everyone involved to have a meeting in the future and discuss the event.

Commissioners Armstrong and Yawer also agreed that is was too soon to make a final decision and that we should wait until May to decide.

Commissioner Janiec said he brought it up was because the Summer Celebration meeting for February was cancelled and a decision will have to be made by May as there is a lot of planning that goes into this event.
