C. Purchase of 2022 Ford Utility Vehicle Through Suburban Purchasing Cooperative

Executive Director Janda stated that based on consensus of the Board at the March 22, 2022 Board meeting, staff has ordered a 2022 Ford Utility Vehicle through the Suburban Purchasing Cooperative at a cost not to exceed \$ 35,207. He said that this vehicle will be purchased with Capital Funds from the 2022-2023 budget.

D. 2022-2023 Tentative Budget & Appropriations Ordinance

Executive Director Janda said the 2022-2023 Budget & Appropriation Ordinance has been prepared in its tentative form and will be placed on review for public inspection prior to its formal adoption in accordance with state statute.

E. Request to Amend Purchasing Policy to Increase Bid Limit Requirements to Match State of Illinois Statute

Executive Director Janda informed the Board that bill SB3050 had recently passed in the Senate and House and is awaiting the Governor's signature. This bill would raise the bid expenditure threshold for park districts to \$30,000 up from the current \$25,000 limit. He said that the current Streamwood Park District bid limit threshold is \$20,000 and has been at that level since 2011.

There were no questions or comments.

F. Request to Declare Miscellaneous Obsolete or Non-Functioning Electronic and Computer Equipment and Old Hoosier Grove Barn Chairs Surplus and Authorize Disposal of Same

Executive Director Janda said that staff has prepared a list of obsolete and nonfunctioning electronic and computer related equipment located at Park Place Family Recreation Center in Partnership with Rush Physical Therapy and Hoosier Grove Barn and request that the Board declare the items surplus and authorize their disposal.

There were no questions or comments.

G. Purchase of Fuel Master Fuel Management System for 360 Schaumburg Road

Executive Director Janda said that staff has requested the Board to concur with its planned purchase of a Fuel Master Management System for the fuel tanks located at the 360 Schaumburg Road property as it will allow us to continue to allocate costs to specific vehicles and departments. He also said that the Fuel Master System costs \$14,840.00 and is available through the Sourcewell Cooperative Purchasing program.

Commissioner Piekarz asked if the tanks were already on the property and Superintendent of Parks & Planning Pickett said they were and that they were still in good shape.

POLICY AND PLANNING REPORT

- A. Strategic Planning Project Update
 - Greg Petry of Greg Petry Consulting made a presentation to the Board on the project and its status. He said senior staff and Commissioner Piekarz met on March 23rd and on April 8th and that the surveys are scheduled to be disseminated to staff and Board members in May. He also informed the Board that in May a separate resident survey will be conducted electronically.
- B. Request from Village of Streamwood to Acquire Kollar Park Through Either Quit Claim Deed Or Long-Term Lease for Development of a Gateway to the Municipal Campus on Irving Park Road

Executive Director Janda said that staff has begun an overview of the property including conditions and improvements for the Board to review next month.

C. Facilities License Agreement with the Catholic Bishop of Chicago to Allow Use of St. John's Ballfield/Green Space for Streamwood Park District Use to Provide Sporting Games, Practices and Related Activities During Non-School Hours from March 1, 2022 Through October 31, 2022

Executive Director Janda stated that the agreement is on hold as the Archdiocese specific insurance requirements are not reasonable and PDRMA will not provide coverage to that extent. Executive Director Janda has now requested PDRMA to negotiate on the Park District's behalf. Commissioner Piekarz asked that since St. John's uses our gym would it not be the same coverage as we have which Executive Director Janda responded that they want more coverage.

D. Contract with Tow Company to Remove Illegally Parked or Abandoned Cars from Streamwood Park District Property

Executive Director Janda explained that the towing contract will provide a legal means to remove improperly parked vehicles only when the Executive Director or his designate requests it.

- E. Resolution 2022-04-02: Safety Policy Statement
 The Board is requested to adopt Resolution 2022-04-02: Promote Workplace Safety
- F. Resolution 2022-04-03-R: Developing a Donation of Land and Cash in Lieu of Land Policy Executive Director Janda said that this policy sets land donation requirements or cash donation in lieu of land donation requirements related to the anticipated impact of the residential development on the park district. He also said this Resolution creates/amends a policy to reflect current best practices.
