APPROVAL OF THE AGENDA

Commissioner Wright moved approval of the agenda as presented and Commissioner Brogan seconded the motion. A voice vote was unanimous for approval; motion carried.

D. 2019 Mowing Contract

Superintendent of Parks & Planning Pickett explained that in November 2016 the District put specifications together to solicit bids from landscape contractors for mowing services at locations throughout the District. The specifications called for pricing on a yearly basis for a three year period with the contract renewable on an annual basis. I am recommending approval of year three of the bid from Cornerstone Land & Lawn Inc. for mowing services during fiscal year May 1, 2019 to April 30, 2020 in the amount of \$57,505.00.

Commissioner Wright moved approval of the bid from Cornerstone Land and Lawn, Inc. for mowing services during fiscal year May 1, 2019 to April 30, 2020 in the amount not to exceed \$57,505.00. The motion was seconded by Commissioner Brogan. Vote on the motion:

E. Sunny Hill Park Paving Change Order

Superintendent of Parks & Planning Pickett stated that the original plans for Sunny Hill Park did not allow sufficient space to accommodate the turn radius of all applicable District vehicles and trailers. I am recommending that we revise the plans through a Change Order so that we can increase the concrete pathway and remove the retaining wall on the south side of the pathway and concrete pad so that we would have sufficient space for the vehicles.

Commissioner Wright moved approval of Change Order for Sunny Hill Park paving and asphalt renovations in the amount not to exceed \$26,421.00 for a wider concrete path, larger concrete pad, additional drainage, additional excavating and additional storm water detention. Commissioner Brogan seconded the motion. Vote on the motion:

POLICY & PLANNING

A. Resolution #2019-4-1-O: Intergovernmental Agreement

Superintendent of Recreation Muenz explained that in the past we had an intergovernmental agreement with Hanover Park Park District for the use of Seafari Springs Aquatic Center. Seafari Springs Aquatic Center will be closed for renovations and repairs throughout the 2019 aquatic season. In an effort to continue offering summer outdoor aquatics use, the Streamwood Park District staff penned an agreement with the Roselle Park District staff. This will allow all Streamwood residents the ability to purchase season passes and daily visits as well as register for swim lessons and rent the aquatic facility at Roselle Park District at resident rates. Commissioner Armstrong asked if we had published anything to the residents yet and Superintendent of Recreation Muenz responded that we will be doing that.

Commissioner Wright moved to approve Resolution #2019-4-1-O: Intergovernmental Agreement with the Roselle Park District for outdoor aquatics use for 2019 aquatics season and the motion was seconded by Commissioner Brogan. Vote on the motion:

President Janiec said that about two weeks ago a letter from the President of the Streamwood High School Booster Club, John Beto, was sent to the Streamwood Park District but he never received it. President Janiec gave the information to Superintendent of Parks & Planning Pickett to see if anyone would be interested in attending the Athletic Golf Outing on May 18th.

DEPARTMENTS/DIRECTOR'S REPORT

- A. Superintendent of Recreation Muenz introduced the newest Recreation Department team member, Adam Vasquez. Adam's responsibilities will cover athletic programming including youth and adult softball, contractual programming, early childhood athletics, affiliate groups, field rentals and Park Place rentals and birthday parties.
- B. Superintendent of Recreation Muenz stated that he met with staff to review new programming for the fall program guide.
- Superintendent of Recreation Muenz said that Spring Soccer began this month with 237 players which is up from 215 in the fall season.
- D. Superintendent of Recreation Muenz said that the Egg Dive that took place on April 19th had a total of 215 participants which last year we only had 177 participants.

- E. Superintendent of Recreation Muenz stated that the 2019-2020 Preschool registration was going well with 73 students already signed up.
- F. Superintendent of Recreation Muenz said that Brunch with the Bunny had 45 participants and that staff estimated participation at the annual Easter Egg Hunt to be about 200-250 children.
- Superintendent of Recreation Muenz informed the Board that staff is working on the preparations for Touch A Truck with a new entry form and also have been working on compiling a contact list.
- H. Superintendent of Parks & Planning Pickett informed the Board that Fleet Manager Jose Reyes has resigned as he found a job closer to his home. We wish him good luck.
- I. Superintendent of Parks & Planning Pickett said that Park Manager Amy Vito will be on medical leave for a few weeks.
- J. Superintendent of Parks & Planning Pickett said that staff has been busy with the two snowfalls we had and also having to do some mowing.
- K. Superintendent of Parks & Planning Pickett said that Park Pride Day has volunteers at 26 parks so far.
- L. Superintendent of Parks & Planning Pickett stated that we will be going to bid for the Park Place electrical issue in about 2 weeks.

COMMISSIONERS' REPORTS

Commissioner Brogan had heard some complaints regarding the volleyball area by Dolphin Park. He said that he had spoken with Superintendent of Parks & Planning Pickett regarding this and that he feels we should do some repairs there.

Commissioner Armstrong received an email from Superintendent of Recreation Muenz about a Village of Streamwood intergovernmental agreement regarding Kollar Pond and she wondered why it vas not an item on the agenda.

PRESIDENT'S REPORT

- A. President Janiec stated that he was involved with the Poplar Creek Library, Woman's Club, Chamber of Commerce and is also on the Summer Celebration Parade committee.
- B. President Janiec informed the Board that Student Government Day was tomorrow and wondered why none of the Commissioners were invited to be part of this day. Superintendent of Recreation Muenz stated that the Village of Streamwood had informed him of what takes place for Student Government Day but they never mentioned who he should invite to be part of this day. President Janiec said that since the Commissioners did not know about it that he would not be attending.
