# THE MINUTES OF THE REGULAR MEETING OF THE STREAMWOOD PARK DISTRICT BOARD OF COMMISSIONERS HELD ON AUGUST 23, 2022 AT HOOSIER GROVE BARN, 700 W. IRVING PARK ROAD, STREAMWOOD, IL

#### CALL TO ORDER/ROLL CALL

Vice-President Raees Yawer called the meeting to order at 7:00 p.m. Present were Commissioners Rick Brogan and Richard Janiec, along with staff members Executive Director Jeff Janda, Superintendent of Parks & Planning Ian Pickett, Superintendent of Recreation Steve Muenz and Finance Manager Sherri Harry. President Larry Piekarz and Commissioner William H. Wright were absent.

All those answering "present" were physically present at the meeting.

Greg Petry presented a working draft of the Strategic Plan to the Board of Commissioners. There were no questions or comments.

#### C. Resolution 2022-08-03-R: NWSRA Member District Annual Assessment (MDAA)

Executive Director Janda informed the Board that the NWSRA bylaws require each member agency to adopt a resolution determining the annual contribution to NWSRA for the fiscal year. There were no questions or comments.

#### D. Ordinance 2022-08-01-O: 2022 Levy Abatement Ordinance

Executive Director Janda explained that this ordinance abates the tax levied for the year 2022 to pay debt service on the General Obligation Park Bonds (Alternate Revenue Source), Series 2022, of the Streamwood Park District, Cook County, Illinois.

## E. Order Calling a Public Hearing Concerning the Intent of the Board of Park Commissioners of the Streamwood Park District, Cook County, Illinois, to Sell Not to Exceed \$1,230,000 General Obligation Limited Tax Park Bonds

Executive Director Janda said that the BINA Hearing Order will be signed by the Board President within a 30-day period of the BINA hearing which will be held on September 27<sup>th</sup>. There were no questions or comments.

#### F. Purchase of ABI Force Z23S Ballfield Groomer

Executive Director Janda said that staff is requesting authorization to purchase an ABI Force Z23S which is the only infield groomer that has been built from the ground up with the sole purpose of caring for the game to make it safe and playable.

#### G. Fitness Equipment Replacement

Executive Director Janda said that staff is requesting authorization to replace fitness equipment at Park Place Family Recreation Center in Partnership with Rush Physical Therapy as the equipment is more than 10 years old and has exceeded its useful life expectancy. He said the equipment will be purchased through a three (3) year installment lease at a cost of \$137,400 plus accrued interest on the balance and at the end of the three year contract the equipment ownership transfers to the Streamwood Park District.

#### A. Jaycee Park Community Meeting and Planning

Executive Director Janda said that he and Commissioner Piekarz will meet with the Jaycee Park neighborhood residents, as directed by the Board, on August 30<sup>th</sup> at 6:30 p.m. to present playground options and related costs provided by playground manufacturer representatives for the park.

#### B. Resolution 2022-08-01-R: Amending the Personnel Policy Manual

Executive Director Janda said that staff recommends amending the policy 6.4 Smoking to include vaping in the prohibited actions.

## C. Resolution 2022-08-02-R: A Resolution Approving and Authorizing the Submittal of an Application for an Open Space Land Acquisition and Development Grant

Executive Director Janda said that the OSLAD application requires a Resolution of Authorization with the submittal package.

## D. Request for Easement at Hoosier Grove Park by Village of Streamwood to Construct 10-Foot Wide Bike/Pedestrian Path as Part of Regional Bike/Pedestrian Plan

Executive Director Janda informed the Board that the Village of Streamwood is requesting an easement for the construction of a 10' bike/pedestrian path that will run along Madison Avenue and along the

northwest corner of the park and connect to the existing pathways near the volleyball court. He said this path is part of the Regional Bike/Pedestrian plan.

E. Potential Grants that the District is Considering/Reviewing

Executive Director Janda said that staff are considering and /or working on several potential grant opportunities including OSLAD for Butterfly Park, ITEP to replace failing trail surface segments that are part of the regional trail system, DCEO Festivals and Attraction for capital improvements and both Kiwanis Legacy of Play and KaBoom! for potential playground replacements.
