The Cook County Clerk's Office has not released the 2022 second-half property tax bills that include the adjusted tax rates and tax extensions by fund. The staff with advice from PMA and Ancel Glink have estimated the 2021 extensions and have suggested an overall levy of more than 105% than the 2021 tax levy to capture the funding entitled to the park district. The Property Tax Extension Limitation Law (PTELL) will reduce the levy to the amounts legally permissible under the tax cap.

D. Resolution 2022-09-04-R, DCEO Grant Submission Authorization

Staff is working on a grant submission for the Illinois Department of Commerce and Economic Opportunity Tourism Attractions & Festivals Grant Program. The Resolution provides authority to submit the grant. The grant is a 50/50 match grant and capital related improvements to the Hoosier Grove Farmstead and Museum are eligible. The minimum grant request is \$15,000 and the maximum is \$500,000. Items being considered include new lighting, new concrete walks, new museum stairs, horse barn siding, and other related items.

VIII. Policy and Planning Report

A. Jaycee Park Community Meeting and Planning.

Commissioner Piekarz, Superintendent of Parks and Planning Pickett, and Executive Director Janda met with the neighborhood residents as directed by the Board on August 30th at 6:30 pm at Jaycee Park to present playground options and related costs provided by playground manufacturer representatives for Jaycee Park. The residents selected the Landscape Structures Option 2 at a cost of \$156,283 installed. During the presentation it was stressed about the need to find funding for the project and that the District is looking into grants, community builds, and potential legislative member assistance. The District has submitted a grant request for \$25,000 to Kiwanis International. Finalists are determined by open voting September 18th through September 30th.

B. Grant Applications that the Park District is working on.

Staff is working on grant applications including OSLAD for Butterfly Park, and the DCEO Festivals and Attractions for capital improvements at Hoosier Grove. The grant opportunities listed require matching local funds and are awarded on a competitive basis.

C. Resolution 2022-09-05-R, Summer Celebration Amended Articles of Incorporation With the Streamwood Chamber of Commerce no longer chartered with the State of Illinois and the Poplar Creek Library's desire to join the Summer Celebration membership, the Articles of Incorporation need to be amended.

- 2. Each person (or representative) is limited to one (1) email submission for public comment, which comment shall not exceed 250 words.
- 3. All comments from the public will be limited to **three (3) minutes per person**. The President or presiding officer reserves the right to suspend or limit the length of time available for all public comments to no greater than thirty (30) minutes.
- 4. All comments must be civil in nature. Email comments will be rejected if the content is slanderous or threatening.
- 5. All other rules for public comments which have previously been adopted and which are not in conflict with these rules shall still be enforced.
- 6. content is slanderous or threatening.
- 7. All other rules for public comments which have previously been adopted and which are not in conflict with these temporary rules shall still be enforced.
