## CALL TO ORDER/ROLL CALL

# BOND ISSUE NOTIFICATION ACT PUBLIC HEARING

Public hearing concerning the intent of the Board of Park Commissioners to sell the General Obligation Limited Tax Park Bonds for park improvement purposes and to refund outstanding obligations of the District.

At 7:01 p.m., Commissioner Janiec moved to open the public hearing and the motion was seconded by Commissioner Wright. Vote on the motion:

President Piekarz announced that the next agenda item is a public hearing concerning the intent of the Board of Park Commissioners to sell not to exceed \$1,230,000 General Obligation Limited Tax Park Bonds for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District and for the payment of the expenses incident thereto and that all persons desiring to be heard would have the opportunity to present written or oral testimony with respect to the proposed sale.

President Piekarz asked if there are any comments from the Board of Commissioners which there were none and there wasn't any written testimony.

President Piekarz asked if anyone would like to present oral testimony or public comment concerning the proposed bond issue. There were no questions or comments from anyone present.

President Piekarz announced that all persons desiring to be heard had been given an opportunity to provide oral or written testimony with respect to the proposed issuance of bonds.

- C. Resolution 2022 -09-02-R: Truth in Taxation

Executive Director Janda explained to the Board of Commissioners that the Cook County Clerk's office has not released the 2022 second-half property tax bills that include the adjusted tax rates and tax

extensions by fund so advice from PMA and Ancel Glink suggested an overall levy of more than 105% than the 2021 tax levy to capture the funding entitled to the park district. There were no questions or comments.

D. Resolution 2022-09-04-R: DCEO Grant Submission Authorization

Executive Director Janda informed the Board that staff is working on a grant submission for the Illinois Department of Commerce and Economic Opportunity Tourism Attractions & Festivals Grant program. He said that the resolution provides authority to submit the grant and that the grant is a 50/50 match grant and capital related improvements to the Hoosier Grove Farmstead and Museum. Executive Director Janda also stated that the minimum grant request is \$15,000 and the maximum is \$500,000 and the items being considered include new lighting, new concrete walks, new museum stairs, horse barn siding and other related items.

# POLICY AND PLANNING REPORT

# A. Jaycee Park Community Meeting and Planning

Executive Director Janda said that he, along with President Piekarz and Superintendent of Parks & Planning Pickett, met with the neighborhood residents on August 30<sup>th</sup> at 6:30 p.m. at Jaycee Park to present playground options and related costs provided by playground manufacturer representatives for Jaycee Park. The residents selected the Landscape Structures option 2 at a cost of \$156,283 installed. Executive Director Janda stressed about the need to find funding for the project and that the District is looking into grants, community builds, and potential legislative member assistance. He said that the District has submitted a grant request for \$25,000 to Kiwanis International and that the finalists are determined by open voting starting on September 18<sup>th</sup> through September 30<sup>th</sup>. There were no questions or comments.

B. Grant Applications that the Park District is Working on

Executive Director Janda said that staff is working on grant applications including OSLAD for Butterfly Park and the DCEO Festivals and Attractions for capital improvements at Hoosier Grove.
