MINUTES OF THE REGULAR MEETING OF THE STREAMWOOD PARK DISTRICT BOARD OF COMMISSIONERS HELD ON OCTOBER 25, 2022 AT HOOSIER GROVE BARN, 700 W. IRVING PARK ROAD, STREAMWOOD, IL

CALL TO ORDER/ROLL CALL

Vice-President Raees Yawer called the meeting to order at 7:00 p.m. Present were Commissioners Rick Brogan, Richard Janiec and William H. Wright, along with staff members Executive Director Jeff Janda, Superintendent of Recreation Steve Muenz and Finance Manager Sherri Harry.

President Piekarz was absent.

All those answering "present" were physically present at the meeting.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

INTRODUCTION OF GUESTS

Guests in attendance were Women's Club members and residents, Annette Porro, Marion Janiec and Pat Diehn, resident Kim Kaeseberg, Linda Byron from Raymond James and Horticulture Supervisor Jimmy Schmidt.

TOPICS FROM THE FLOOR

Women's Club member, Pat Diehn, spoke about the history of the Golden Agers Club and wondered why it has never been reinstated since Covid. She said the seniors use to have some senior programming and the use of the indoor track but now nothing is offered for them.

Executive Director Janda responded that she should come to his office and they can discuss this as this is the first time he has heard anything about this issue.

Board members congratulated Commissioner Richard Janiec and Commissioner William Wright on their 15 years of service to the Streamwood Park District.

FINANCE REPORT

A. Monthly Expenditures/Payroll

There were no questions or comments.

B. Monthly Financial Reports

There were no questions or comments.

C. 2022 G.O. Limited Park Bond Issuance

Executive Director Janda said that included in the Board packet is Ordinance 2022-10-01-O: an ordinance providing for the issue of approximately \$1,750,000 General Obligation Limited Tax Park Bonds, Series 2022A, for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the Park District, to provide the revenue source for the payment of certain outstanding bonds of the Park District, and for the payment of the expenses incident thereto, providing for the levy of a direct annual tax to pay the principal and interest on said bonds and authorizing the sale of said bonds to the purchaser thereof.

There were no questions or comments.

D. 2022 G.O. Limited Park Bond Bids

Linda Bryon of Raymond James presented the bids received related to the issuance of the 2022 G.O. Limited Park Bond Issue. She stated that BMO Harris was the only bidder but came in at a good interest rate of 4.124%.

There were no questions or comments.

E. 2021-2022 Audit Status

Executive Director Janda informed the Board that auditor Joseph Julius notified the District that the 2021-2022 annual audit of the Streamwood Park District financial reporting is delayed three to four weeks due to staffing issues related to Covid-19. Auditor Julius said that his office would request and file the audit extension with the appropriate State of Illinois agencies.

There were no questions or comments.

F. 2021 2nd Half Property Taxes – Status

Executive Director Janda informed the Board that he spoke with the Cook County Clerk's Tax Extension Office and they said the estimated timeline for the rate determination sheets will be available mid-November with a two-day period for local agencies to review and make corrections. He also said that the 2021 levy second half tax bills are anticipated to be mailed around Thanksgiving with a due date of December 31st.

There were no questions or comments.

G. 2022 Tax Levy

Executive Director Janda said that staff is recommending that the Truth in Taxation Hearing for the Levy be held on November 15th or December 13th based on the information received from the Cook County Clerk's office. He explained that if the county can complete the rate determinations earlier than anticipated by their timeline then the 2022 tax levy can be drafted based on the actual aggregate extension and not an estimated aggregate extension based on the 2020 levy aggregate extension plus the 2021 CPI of 1.4%.

There were no questions or comments.

H. 2023 PDRMA Employee Health Plan

Executive Director Janda stated that the health plan for 2023 will remain the same as previous years with the exception that the Davis Vision will now administer the vision plan.

There were no questions or comments.

I. Weather Monitoring/Severe Weather Public Notification System

Executive Director Janda said that staff has investigated the status of the current Thor Guard Weather Notification System and compared it with newer more modern technologies that will improve

the reliability and performance of severe weather public notification. He said that the current Thor Guard system utilize older technology and that the units are more than 15 or 20 years old and require a lot of staff maintenance and repairs. Executive Director Janda is requesting authorization to enter a seven-year lease for the Perry Weather system to replace Thor Guard units at Hoosier Grove, Rahlf's Woods, Park Place and Sunny Hill Park.

There were no questions or comments.

J. Happ Builders, Inc. Payment Application #1 for Elevator Addition and Remodeling at the Community Center in the amount of \$82,800

Executive Director Janda explained that the contractor has requested payment related to a 50% deposit required from the elevator sub-contractor for the elevator construction work which the site work is scheduled to begin in spring 2023

There were no questions or comments.

K. Integrity Environmental Professional Asbestos Services Proposal for Asbestos Abatement Project Design, RFP Preparation, Abatement Project Management, Air Monitoring, and Reporting Services In-Tact Flooring Material Abatement Work Community Center Building Renovation Project in the Amount not to Exceed \$6,630

Executive Director Janda informed the Board that the Community Center Phase 2 Environmental Report confirmed the presence of asbestos in some of the floor tile and mastic which we need to address.

There were no questions or comments.

Marco Copier Lease for Administration Building and Park Place Family Recreation Center in Park Place Family Recreation Center in Partnership with Rush Physical Therapy Executive Director Janda said the staff is requesting authority to enter a new lease for color copiers at both the Administration Building and Park Place Family Recreation Center in Partnership with Rush Physical Therapy. He explained that the 60-month lease will replace the one color and one black and white copier with two color copiers.

There were no questions or comments.

M. 2023 Vehicle Purchases Through Suburban Purchasing Cooperative

Executive Director Janda informed the Board that Ford has cancelled the order for the 2022 Ford Explorer as they are unable to build the vehicle due to parts availability issues. He said he plans to reorder the unit in the 2023 model if it will be available and that the pre-order forms are due immediately as the order window for the Ford is November 7-10th. Executive Director Janda also said staff are planning to order additional vehicles as part of the vehicle replacement program, including at least one F-250 and one 4x4 Ford-F450 Chassis to serve as a dump truck and plow. There were no questions or comments.

POLICY AND PLANNING

A. Jaycee Park Playground

Executive Director Janda informed the Board that even though the Streamwood Park District entry in the Kiwanis Legacy of Play Contest finished in the top ten it was not selected by the panel of judges. He said we are going to review financial resources and other potential means to replace the playground as requested by the neighborhood.

B. Resolution 2022-09-05-R: Summer Celebration Amended Articles of Incorporation
Executive Director Janda said that staff is still working with the Village of Streamwood and the attorney to address the related questions raised at last month's meeting regarding

the Articles of Incorporation.

Commissioner Wright said that the Executive Director's evaluations have been received from all the Board members and have been complied into an overall performance review report.

D. Vine Park Playground Removal

Executive Director Janda would like the Board to reaffirm its previous decision and vote to remove the playground at Vine Park and to direct the staff to proceed with planning and implementation of a redevelopment plan for the park.

E. Annual Harassment Training

Executive Director informed the Board that staff and elected Board members are required to complete the annual Harassment Training as mandated by the State of Illinois. He said this training must be completed by the end of the year and that a training link will be sent to all Board members.
