## STREAMWOOD PARK DISTRICT ORDINANCE 2022-12-01-0

# AN ORDINANCE FOR THE 2022 LEVY AND ASSESSMENT OF TAXES FOR THE STREAMWOOD PARK DISTRICT, COUNTY OF COOK, STATE OF ILLINOIS

WHEREAS, on the 10<sup>th</sup> day of May, 2022, the Board of Commissioners of the Streamwood Park District, Cook County, Illinois, passed its annual Appropriation Ordinance; and

WHEREAS, on September 27, 2022, not less than 20 days before the date of this Ordinance, the Board of Park Commissioners adopted Resolution 2022-09-02-R to establish an estimate of levy pursuant to the Truth in Taxation Act; and

WHEREAS, on December 13, 2022, the Board of Park Commissioners convened a public hearing pursuant to the Truth in Taxation Act pursuant to notice published in the Daily Herald, on December 2, 2022.

**NOW THEREFORE, BE IT ORDAINED** by the Board of Commissioners of the Streamwood Park District, Cook County, Illinois;

<u>Section 1</u>. That there be and is hereby levied and assessed upon all taxable property within the corporate limits of the Streamwood Park District, Illinois, as the same is assessed and equalized for state and county taxes, a sum equal to \$4,154,246 for the following purposes:

#### A. <u>CORPORATE FUND</u>

For the general corporate purposes of the Park District (70 ILCS 1205/5-1; 5-3 and Public Act 97-974)

#### TOTAL CORPORATE TAX

\$2,000,000

#### B. **RECREATION FUND**

For the recreational programs of the Park District (70 ILCS 1205/5-2; 5-3a and Public Act 97-974)

#### TOTAL RECREATIONAL TAX

\$1,322,072

#### C. MUSEUM FUND

For the maintenance and operation of the Museum of the Park District (70 ILCS 1290/2)

#### **TOTAL MUSEUM TAX**

\$30,000

For Park District Participation in the Illinois Municipal Retirement Fund for Park District employees (40 ILCS 5/7-171)

Section II. That the taxes so levied and assessed as aforesaid upon the taxable property subject to taxes within the Streamwood Park District, shall be collected and enforced in the same manner and by the same officers as general taxes are now collected and enforced under the laws of the State of Illinois and shall be paid by officers so collecting the same to the Treasurer of said Streamwood Park District.

Section III. That the Secretary of the Streamwood Park District be and is hereby directed to file this Ordinance with the County Clerk of Cook County, State of Illinois, who is authorized and directed in the manner provided by law to ascertain that rate percent which, upon the total valuation of the taxable property within the District, as the same are assessed and equalized for state and county purposes, will produce an amount as herein legally levied, and to extend such tax pursuant to the statute.

<u>Section IV</u>. Pursuant to Section 4-4 of the Park District Code (70 ILCS 1205/4-4) neither the Budget and Appropriation Ordinance of the District for the current fiscal year beginning May 1, 2022 and ending April 30, 2023, nor any other Budget and Appropriation Ordinance is intended or required to be in support of the tax levy made in this ordinance.

**Section V.** The unexpended balance of any item or items levied in and by this ordinance may be expended in making up any deficit of any item or items in the same general appropriation and levy made by this ordinance. The unexpended balance of the tax for general corporate purposes from the preceding year will be accumulated and set aside for the purposes of building repairs and improvements in a capital improvement fund, provided that the balance of such fund does not exceed 1.5% of the aggregated assessed valuation of all taxable property within the District.

<u>Section VI</u>. If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining such items of the remaining portion of this Ordinance.
