# F. Grant Agreement No.OS-23-2346 Between the between The State of Illinois, Department of Natural Resources, and the Streamwood Park District for the OSLAD Program Redevelopment of Butterfly Park.

The Illinois Department of Natural Resources has prepared a grant agreement for the redevelopment of Butterfly Park as submitted and awarded through the OSLAD program. Staff recommends approving the grant agreement and authorizing the signing of the agreement by the Executive Director on behalf of the Streamwood Park District.

# F. Proposal for Gewalt Hamilton Associates, Inc. Professional Design and Construction Administration Services for Streamwood Park District Butterfly Park with an Estimated Total Fee and Reimbursables of \$85,000

GHA has provided a proposal for Professional Design and Construction Administration Services for the Butterfly Park OSLAD project at an estimated cost of \$85,000. Staff recommend accepting the proposal which includes project design and construction administration services for the OSLAD project.

#### H. DCEO Potential Capital Grant for Spa Pool and Park Place Pool Resurfacing

The District has been contacted by the State of Illinois Department of Economic Opportunities regarding a Capital 2019 grant for \$300,000. The use of the grant is planned for the replacement of the Park Place Spa Pool and resurfacing of the Lap and Activity Pool. Original estimates related to the spa replacement have nearly doubled to \$323,000. Pool resurfacing costs are estimated at \$130,000-\$140,000 and will need to be a separate project. Staff are requesting authority to complete the grant application and enter into the grant pending funding availability.

### I. Jaycee Park Playground Replacement

Staff have been working to secure contractors for the excavation and concrete work related to the playground replacement and have found continuing inflation, and material and labor shortages are increasing anticipated costs and/or limiting available contractors. Staff are requesting approval to publicly bid for the excavation and concrete work, if needed, as the bidding threshold is \$30,000. Staff are also requesting authority to order the poured-in-place surfacing through Sourcewell joint purchasing at a cost of \$ \$70,056.

- 1. All speakers may submit public comments via email to the designated park official from the time the agenda is made public up to 15 minutes prior to the scheduled meeting. The email must include the speaker's name and address. Public comments will be read aloud by a member of the Park Board or the Executive Director during the scheduled meeting. - 2. Each person (or representative) is limited to one (1) email submission for public comment, which comment shall not exceed 250 words.
- 3. All comments from the public will be limited to **three (3) minutes per person**. The President or presiding officer reserves the right to suspend or limit the length of time available for all public comments to no greater than thirty (30) minutes.
- 4. All comments must be civil in nature. Email comments will be rejected if the content is slanderous or threatening.
- 5. All other rules for public comments which have previously been adopted and which are not in conflict with these rules shall still be enforced.
- 6. content is slanderous or threatening.
- 7. All other rules for public comments which have previously been adopted and which are not in conflict with these temporary rules shall still be enforced.
