

**MINUTES OF THE LOCAL GOVERNMENT EFFICIENCY COMMITTEE

**CALL TO ORDER/ROLL CALL**

**LOCAL GOVERNMENT EFFICIENCY COMMITTEE REPORT REVIEW AND DISCUSSION**

Chief Executive Officer Janda explained that this law requires local governments that may levy any tax must form a committee within one year of the effective date of the Act and at least once every 10 years thereafter. He said the committee will study efficiencies and report recommendations regarding those efficiencies and increased accountability pursuant to 50 ILCS 70/1.

CEO Janda recommended that we add Superintendent of Parks & Planning Ian Pickett and Superintendent of Recreation Steve Muenz to the committee which everyone thought was a good idea.

**QUESTIONS**

Michelle Nugent asked if this committee can even help the Park District in any way. CEO Janda responded that it could increase our transparency.

Commissioner Brogan said that the government just wants to make sure that the Park District works as efficiently as possible so that citizens tax dollars are put to good use.
